

EDILIANS GROUP STRENGTHENS ITS PRESENCE IN SOUTHERN EUROPE WITH THE ENTRY INTO AN AGREEMENT FOR THE ACQUISITION OF INDUSTRIE COTTO POSSAGNO

Dardilly, January 28, 2026 – **EDILIANS GROUP**, the Southern European leader in sustainable terracotta roofing, announces the signing of an agreement to acquire Industrie Cotto Possagno, an Italian family business founded in the eighteenth century and recognized for its know-how in the manufacture of clay tiles. This strategic operation is part of the group's international development dynamic, already industrially present in France, Spain and Portugal, and accelerates its deployment on the Italian market as well as the export market.

With more than 150 employees, annual revenues of approximately €40 million, Industrie Cotto Possagno benefits from a strong territorial anchorage, driven by its history and its commercial brands at the service of a rich range of products, secular expertise and complete control of its supply chain thanks to its 4 operating quarries and industrial footprint with four main production lines.

"This acquisition, which is expected to close in April 2026, strengthens our leading position in Southern Europe by taking on a large and historic clay tile market. This allows us to offer our customers roofing solutions that combine tradition, technical performance and environmental commitment," says Pascal Casanova, President of **EDILIANS GROUP**.

"This operation represents an important opportunity for Industrie Cotto Possagno: we are joining a solid group with an international outlook, with which we share fundamental values such as quality, manufacturing tradition and a commitment to sustainability. We are confident that this integration will enable us to further strengthen our presence on the Italian market and to accelerate our development on foreign markets, while preserving our identity and the skills present in our territory", says Alessandro Vardanega, Chairman of the board of Industrie Cotto Possagno S.p.A.
